1 Up to € 1.250 reimbursement per year

- **Per year of registration** you will receive per person a **new annual budget** for reimbursements via Dentalia Plus.
- Your **annual budget** depends on the **year of registration** that you are in at any given moment:
 - After 6 months of registration: reimbursement of up to € 350
 - After 1 year: up to € 650
 - After 2 years: up to € 1.250There is a maximum reimbursement of € 1.050 for prostheses, implants, periodontics and orthodontics.
- Your new annual budget with Dentalia Plus starts each time on the **date of registration**.

For example:

Registration with Dentalia Plus on August 1, 2015:

→ You start each time with a new annual budget of € 1.250 on August 1.

2 It's worthwhile having a dental check-up

Be sure to go to the dentist's once a year for a check-up. This will entitle you to the maximum reimbursement.

For example:

- You registered on August 1, 2015 and you had a €1000 crown fitted on August 1, 2017.

You **did not go to the dentist's in 2016**.

→ Dentalia Plus reimburses €500.

- You had a €1000 crown fitted on August 1, 2017.

You **did go to the dentist's in 2016**.

→ Dentalia Plus reimburses €800.

3 How to get a quick reimbursement

1. Print out a reimbursement request.
You can find the form in the Online Office

2. Have the reimbursement request filled in by your dentist.
3. Then send us the reimbursement request filled in, along with the dentist's bill.

4 Handy reimbursement overview in the Online Office

- **Did you forget your registration date?**
You can easily find all your info in the Online Office.
- There you can also find an **overview** of what has already been reimbursed during your current year.
- From now on, we'll also send the **reimbursement detail** automatically to your **e-Box**, your secure letterbox in the Online Office.

5 Reimbursement for every kind of dental care

- **Preventive dental care** (waiting period of 6 months)
 - *Dental care to detect developing tooth problems before they get worse. For example, the removal of tartar.*
→ 100% reimbursement of your costs.
- **Curative dental care** (waiting period of 6 months)
 - *Technical treatment of tooth problems. For example, tooth extractions, mouth X-rays, fillings.*
→ 50% of your costs reimbursed, if you've not had a dental check-up in the previous year.
→ 80% of your costs reimbursed, if you have had a dental check-up in the previous year.
- **Orthodontics** (waiting period of 12 months)
 - *Correction of incorrectly positioned teeth with a brace or brackets*
→ 60% of your costs reimbursed.
- **Prostheses, implants and periodontics** (waiting period of 12 months)
 - *Prosthetics and implants are devices that replace one or several teeth. Periodontics treats diseases and conditions of the gums, the ligaments and the tooth sockets.*
→ 50% of your costs reimbursed, if you've not had a dental check-up in the previous year.
→ 80% of your costs reimbursed, if you have had a dental check-up in the previous year.

You are entitled to cancel your contract within a period of 3 months from the date of this notification, by registered letter, by submitting your cancellation letter with an acknowledgement of receipt or by using the services of a bailiff. The 2018 Dentalia Plus tariffs are indexed by 2,27%, based on the evolution of the consumer price index of the month of April 2017, compared to that of April 2016. (cf. article 8 of the statutes).
