Tariffs: increase of 1,29%, in agreement with the Regulatory Service for health insurance funds based on article 21octies §2 of the law of 9 July 1975.

What will you be reimbursed?

- Send us a copy of your hospital invoice along with the settlement calculation of your hospitalisation insurance via your employer.
- Enclose a filled-in reimbursement form for Hospitalia.

What if you turn 65 years of age?

- Hospitalia Continuity automatically stops when you turn 65.
- You can immediately join Hospitalia or Hospitalia Plus. Hospitalia Plus offers the widest coverage.
- We will send you the necessary documents.
- Send us the filled-in documents, along with an attestation of registration to the hospitalisation insurance via your employer.

Inform us immediately of any changes in your family situation.

- For example a birth, death or a divorce.
- Any late or incorrect declaration could have consequences for the coverage of your Hospitalia Continuity policy.
